Archivist Report for the 1955 / 1956 Season

The Executive Committee met on September 11 at 9:00 p.m. after church services at the home of Dean Arnold Bowman to discuss programs for the season.

At a general meeting at Memorial Lutheran Church in October programs were discussed for the season as well as Subscriber Membership in the Chapter. A Subscriber Member would be one who never studied or played organ but had an interest in promoting the policies of the Chapter. The Treasurer, Esther Gibbel, reported a balance of \$529 in the Treasury. In answer to a letter from Newell Robinson, Regional Chairman, it was decided that \$5 would be sent to support the Regional Young Organists Contest.

On November 29 the Chapter met at Fourth Evangelical and Reformed Church. Christmas anthems and organ music were discussed. On December 4 a public organ recital of Advent and Christmas music was presented at Salem Evangelical and Reformed Church. On December 10 the annual Christmas recital and party was held at the home of Dr. Rhein.

There was no meeting of record for January of 1956.

On February 9, 1956, a meeting was held at Epworth Methodist Church. Various items of business were brought before the group including the appointment of a nominating committee. Recordings of organ music made by prominent organists constituted the musical part of this meeting.

Seventy singers presented "The Crucifixion" by Sir John Stainer on March 4 at the Derry Street Evangelical Church. Donald Golden, organist and choir director of the Evangelical and Reformed Church of East Berlin, gave an organ prelude. David Schoffy of Camp Hill played the offertory.

On April 21 a panel discussion "Pulpit, Choir Loft, and Pew" was presented at Market Square Presbyterian Church. Panel members were National President Dr. Lewis Elmer for the organists; Dr. Jacob Hikinem of Gettysburg Seminary for the clergy; and Mrs. Richard Miller gave the views on the pew. Questions presented were based on what each of the areas expected from the others.

On May 17 a recital was given by Virgil Fox at Market Square Presbyterian Church.

Chapter Procedures Revised

Our Chapter Procedures, adopted in 2012, have been revised again to match new revisions to the national model, to change our election process, and to fix a few more noted inconsistencies and omissions.

The big change made in this revision is the move to biennial elections. Currently, officers serve one-year terms and may be reelected for a total of three terms. In the new model, officers will serve two-year terms and may be reelected one time for a total service period of four years. Currently, members at-large are elected to three-year terms and we have three classes of three. In the new model, members at-large will be elected to four-year terms and the total number of these members will be reduced from nine to six with two three-members classes. Three members at-large would be elected in 2016 to four-year terms, in 2017 three current members would end their terms bringing the number down to six, and in 2018 another class of three will be elected putting us on track with the biennial pattern.

The revision was approved by the Chapter Executive Committee on April 14 and will be submitted for official adoption at the annual meeting on May 12. Then the document will be submitted to the National Vice President and the Mid-Atlantic Regional Councillor.

The revised document is posted on the Chapter Website at the bottom of the main page: harrisburgago.org. A link to this document has also been shared via e-mail. Chapter Members are encouraged to review the document and communicate to the Chapter Secretary, Karen Appel at hinote@comcast.net or 717-599-5809 immediately if issues are noted.

Anyone in need of a printed copy should also contact the Chapter Secretary.

PLEASE NOTE: paper copies of these procedures will not be available at the annual meeting.

Throne Fund for Adult Education

Guidelines and applications for the Throne fund are now available on the Chapter website in the education section, or by request.

In 2011 a gift was given to the Harrisburg Chapter AGO from Mt. Zion Lutheran Church, Churchtown from a bequest of Ida Enck Throne who served that congregation as organist. The money was given to help train organists. The Harrisburg Chapter earmarked this fund to promote adult education.

Dean Gingrich convened the meeting at 7:00 and asked everyone present to state their name and bring the Board up to date on their activities. Father Lease read words of scripture and prayer.

Requests of the Dean:

- Called for a motion to adopt the agenda. It was moved by Zack Sten and seconded by Carol Hunter. Ratification of the following email actions taken between the November and February meetings:
 - (1) A \$300 donation was sent to the Philadelphia Chapter in support of their annual January Jumpstart event. This action was moved by Kathy Gates and seconded by Carolyn Wright. Acceptance by the Board was by vocal ayes.
 - (2) On January 16th, 2015, the Dean recommended that Charles Yocum, Tony Ciucci, Helen Anthony and Darrell Woomer serve as the Nominating Committee with Dr. Robert Lau, Chair. Motion to accept by Zack Sten and seconded by Ray Edmison. Vocal ayes from the Board approved this action.
 - (3) The Dean asked for approval of Dr. Ralph Kneeream to fill the Chair of Professional Development vacated by Brian Rotz. It was moved and seconded by Carol Hunter and Ken Walker respectively. Board gave vocal approval.

Dean:

Made the Board aware of the updated Chapter Management Handbook approved by National, including these highlights:

- (A) Local chapters are to be encouraged to look for more creative ways to use technology in communicating with members and with organizations which may be interested in supporting the AGO chapter. Email lists could be developed to notify groups of upcoming events. Kathy Gates suggested that a card and/or flyer be developed with contact information that would be available at all programs open to the public.
- (B) We need to think about how much longer we need to print a newsletter. Everything is available on the website. Encourage one of our younger members to move forward in these efforts.
- (C) Directed the Board to read Dr. Thurman's letter of thanks for our gift of \$500 to the Annual Fund.

Secretary:

Asked the Board to forward information on anyone's illness or other situation in which we could keep that member in our

prayers. Informed members that some people prefer not to have information publicized and care must be taken as to what is disseminated among the membership.

Treasurer:

- Zack presented a three page report – the first is a synopsis of end of January balances.
- The second page is a detailed report on the checking account. Shawn gave an explanation of all the debit/credit entries with regard to Jumpstart registration.
- The third page compares actual expenditures against amounts budgeted. The largest over expenditure was for the chapter directory. Open ended discussion on how to deal with the directory was carried forward from the November meeting. Noted that there will no longer be a specific period of time for members to join or renew their membership. Each individual's renewal period begins when National receives their dues. It will be a rolling enrollment. There will be no more partial year memberships.

Chaplain:

No report but wished everyone a Happy Mardi Gras before Lent.

Standing Committee Reports:

All reports are included in a packet of information provided by the Dean for the Board members to peruse. They were considered and accepted with minimal discussion, with the following exceptions:

- Membership: The report was mistakenly overlooked and has been incorporated in the final copy of committee reports for the record.

Nominations: Dr. Lau announced the slate of officers for the 2015-2016 year are as follows: Dean, Shawn Gingrich, Secretary, Karen Appel. At-large Board nominees (2015-2018) are Deborah Dillane, Robert Lau, and Christopher Prestia.

The position of Treasurer was unfulfilled at the time of the meeting. A candidate will be identified and submitted to the Board via email for acceptance before the slate is officially recorded. (Since the meeting, Rick Zentmeyer has been nominated and through email communication the Board has accepted by consensus.)

- Professional Development: The report contains 12 points of responsibility of the person chairing this Committee. Professional Development and the chair of Education must work closely together in some areas.

Program: Ken Walker expressed concern as to why some of the Throne scholarship money was used to pay for members attending Jumpstart. Shawn expressed his opinion that nothing is spelled out for

usage of the funds except to state that it is to be used to further adult education. Discussion centered around how all the scholarship monies are used, and it was the consensus of the Board that clarification and more specific guidelines need to be developed within each scholarship fund. To date, the Education Committee had the ability to decide the fund use without approval by the Board. Until this becomes clear by an act of the Board, scholarships will be approved by the Board. An ad hoc committee comprised of Ralph Kneeream, Carol Hunter and Shawn Gingrich will convene to develop guidelines for the Throne Fund and review the other scholarship funds for clarification, if needed.

No action was required on any of these discussions. The reports will be attached to the officially recorded set of minutes and available upon request.

New Business:


The Dean called for the acceptance of the slate of nominations presented by Dr. Lau. Voice acceptance was given.

- The Program for 2015-2016 was presented by Faith Matthews. Based on the previous discussion re usage of scholarship monies, the following motion was made by Karen Appel: move to accept the program and budget estimates as proposed for each program with the exception of January Jumpstart. Funding for this program will be revisited after guidelines are in place for all of our scholarships. However, January Jumpstart will be our program for that month.
- A copy of a signed agreement was included in the meeting packet setting forth the expenses for Rhonda Edgington's seminar on October 3, 2015. This will be a co-sponsored event with Messiah College. **Per the agreement, the College and AGO will split the costs, each providing 50% of a stipend of \$1,500 plus the cost of airfare estimated to be \$350 payable to Rhonda Edgington.** The Dean called a motion to approve the expenses for Rhonda's expenses. It was moved and seconded and approved by voice vote.
- The Dean called for a motion to adopt next year's budget as presented. It was moved and seconded and approved by voice vote.
- The Dean asked if our Chapter would consider hosting a POE+. An application must be submitted by March 15, 2015 for consideration in 2016. It was moved by Ralph Kneeream and second by Ken Walker that this be pursued. The Board gave vocal approval. The Dean will submit the application. Dean stated that our next gathering is the annual meeting and banquet on May 12 at Colonial Country Club and all Board members are expected to attend.

Adjournment:

The meeting adjourned at 8:50 p.m.
